### 1. Sample of Work

- Please submit a photograph or sample of your work (no slides please). Materials must be picked up following the jury process at the below address.
- Please complete the enclosed DIFM application and mail it to/or drop it off at our office address below with a photograph or sample of your work.
- The application deadline is Noon on Thursday, April 14, 2011.

### 2. Selection

- No vendor is guaranteed acceptance in the DIFM and artisan work is subject to a selection process. Vendors that are accepted into the 2011 DIFM will be notified by Wednesday, April 20th. However, the sooner we receive your sample, the sooner we will respond.

### 3. Place of Business

- The Daniel Island Farmers Market does not accept applications from artisans residing outside the Lowcountry counties east of I-95. These counties include Charleston, Dorchester, Berkeley and Colleton Counties.
- Tents: All Artisans are required to supply their own 10x10 pop-up tent that meets DIFM specifications. All vendors must supply weights to anchor their tent.

## INSURANCE WAIVER
