The Daniel Island Farmers Market will be held each Thursday from April 28th, through September 29, 2011. Vendors agree to participate for the entire Market season. Exceptions are considered on a case-by-case basis prior to the beginning of the Market season.

**Market Fees:**

There will be no fees to participate in the Market. However, all participants must be approved by DIFM.



Food Vendors Certification:

I certify that the food items I offer for sale in the Daniel Island Farmers Market, as per the attached list, will have been prepared by me in a South Carolina Department of Health and Environmental Control (DHEC) or Department of Agriculture approved kitchen.

I have read, understand, and agree to comply with the 2011 Daniel Island Farmers Market General Rules and Regulations as well as the Food Vendor Rules and Regulations. I understand the violations and sanctions, including suspension and disqualification. I understand selling privileges can be revoked by Daniel Island at any time.

I have attached a copy of my City of Charleston business license, a copy of the 2011 DHEC or Department of Agriculture certification, and a list of the items I plan to sell during the 2011 Season of the DIFM. I understand that my kitchen is also subject to inspection by the DIFM staff and DHEC.

I understand that no food vendor is guaranteed acceptance in the DIFM and is subject to approval of Management. I understand that all Food Vendors accepted into the 2011 DIFM will be expected to participate in all scheduled market dates.

The Daniel Island Farmers Market does not accept applications from food vendors residing outside the Lowcountry counties east of I-95. These counties include Charleston, Dorchester, Berkeley and Colleton Counties.

Food Vendors agree to be bound by the attached rules and regulations.
